## ROOKIE DAY TERMS AND CONDITIONS

- I hereby give my child(ren) permission to participate in all Camp Havaya—Rookie Day sponsored activities. I understand that this entire agreement applies to all such activities.
- I agree that Camp Havaya has my permission to use photographs, video or likenesses of my child for promotional purposes, unless I indicate otherwise in writing.
- I agree that Camp Havaya may send my family periodic information via e-mail.
- I have read and approve of this application in its entirety. I hereby release the Jewish Reconstructionist Camping Corporation (JRCC), the Reconstructionist Rabbinical College (RRC), and their respective officers, directors, employees, volunteers, agents, and other representatives from any and all responsibility of any nature for such actions and for any loss or damage to property or personal injury to my child while attending Camp Havaya, regardless of how such injury or harms arise, and regardless of who is at fault.
- It is agreed that any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, shall be resolved exclusively in a court of competent jurisdiction located in Pike County, Pennsylvania according to the existing commercial rules of the American Arbitration Association and the substantive laws of Pennsylvania.
- I understand that part of the Rookie Day experience involves terrain, equipment, activities and group interactions that may be new to my child, and that they come with uncertainties and risks (including injury, paralysis and up to and including death) beyond what my child may be used to dealing with at home. I am aware of these risks and I am assuming them on behalf of my child. I realize that no environment is risk-free and so I have instructed my child on the importance of abiding by Camp’s rules. My child and I both agree that they are familiar with these rules and will obey them.
